RETAIL QUALIFICATIONS

To place a wholesale order, you must be registered as a retail business, and submit the Wholesale Terms and Conditions Agreement [Download] to RAM Marketing LLC, makers and marketers of Passage Pillows. You must also submit a PDF of your sales tax ID along with this application.

BRAND EQUITY PRESERVATION

RAM Marketing and its retail partners agree to a unified pricing structure to protect the brand and products of the company and the margins for our partners worldwide. Retailers that commit to protecting their margins and our branding and pricing are welcome partners. By signing this agreement, retailers are committing to not re-sell our products for less than 15% below Suggested Retail Price (SRP) on the order form. SOFT Style reserves the right to terminate any account that does not honor this Brand Preservation Policy.

ORDERING PROCESS

RETURNS

All items are unconditionally guaranteed against defects in materials and workmanship. All returns must be pre-authorized and in sale-able condition. Email RAM Marketing for an authorization code prior to sending your return – it must be included with any return. Authorized returns made within 60 days of purchase with receipt will receive a full refund or credit less shipping and handling charges. Merchandise credit must be used within one year of issuance. No returns after 60 days. Please insure your return — RAM Marketing cannot be responsible for lost or damaged items.

INTERNET RETAILING

Retailers are permitted to resell RAM Marketing products in their own stores and online on their company store sites ONLY. RAM Marketing will support you with images for your site. Retailing on aggregators/re-seller sites, such as Amazon and EBay, is prohibited. RAM Marketing products will be sold to end customers only. We do not accept 3rd party sellers on Amazon or any other consumer site. If a retailer violates this policy or the pricing policy, it will be required to immediately return product at its expense plus a 20% restocking fee.

SHIPPING AND HANDLING

Shipping and Handling charges will be based on weight and size, with a minimum charge of \$12.95. Free shipping on orders over 12 units.

SHIPPING TIME
